You do not need to enter every week. You can start C-WAGS in Level 1 or Level 2 or run them concurrently

For Ranger Classes you must have the Ranger Level 1 title before running Ranger Level 2

For Dasher Classes you must have the Dasher Level 3 title before running Dasher Level 4

If entries are not sufficient in a round, we may delete the round or change it to another level

Where there are two rounds of the same level on one date, they will be run back-to-back.

LEAGUE PLAY is one trial held over a series of dates. All results are recorded as if they happened the last date of the league. Within the league trial, once a level is completed move-ups to the next level are allowed.

Facilities

- ☐ The trial will be held indoors on foam mats, Great Mats. Indoor shoes are required when inside on the blue mats.
- ☐ There are washrooms and water available onsite.
- ☐ Benching will occur in your vehicle, so please bring what you need to keep you and your dog(s) comfortable in variable weather conditions.
- ☐ Dogs must be benched in your vehicle when they are not in the ring or being walked. Dogs are not to be out in the parking lot. Absolutely no off leash dogs and no dog-to-dog contact. Dogs must be kept a minimum of 15' apart at all times.
- ☐ Any dog engaging in aggressive behaviour at any time will be required to leave the trial grounds.
- ☐ All children must be supervised by a parent not competing in the trials.
- ☐ Anyone observed disciplining their dog in a manner that offends a judge's sensibilities will be excused and will forfeit entry fees.

Notice to Competitors

1. Good As Gold's C-WAGS Scent Leagues are scheduled to run from 9:00am until approximately 2:00pm.
2. All breeds of dogs and mixed breeds are eligible to compete in C-WAGS events. These events are open to reactive dogs. Dogs must be registered with C-WAGS to compete.
3. Dogs that are physically challenged are allowed and encouraged to compete, providing they do not show evidence of being in pain or discomfort. The Judge shall excuse any dog that appears to be in pain or discomfort during the competition. A Judge's decision is final.
4. Owners who are physically challenged are allowed and encouraged to compete.
5. Female dogs in season may not compete. Refund will be given upon receipt of veterinarian documentation.
6. Dogs exhibiting signs of aggression that threaten the safety of other dogs or humans shall be excused from competition at the discretion of either the Judge or the Trial Chairperson or Advocate. If the Trial Chairperson believes it is necessary to ensure the safety of others, he or she shall request that the dog be removed from the showgrounds or confined in such a manner as to remove the threat to others.
7. Dogs must be at least six months of age to compete.
8. Dogs may register with C-WAGS up to the day of the trial. <https://c-wags.org/dog-registration/online-registration/>
9. Awards: Qualifying flats will be awarded to every team who successfully completes an event. C-WAGS does not offer placement ribbons. Title ribbons will be available for teams who have successfully completed four runs under 2 judges at the same level. Qualifying flats will not be awarded for ACE legs however there are ACE title ribbons.
10. Refunds: Refund will be given if the spot can be filled from the wait list and notice is given a minimum of 5 days preceding the trial date. All refunds are subject to a \$25 administrative fee. Selling or trading runs with other competitors is not permitted. Refunds will be issued after the completion of the League.

General Agreement

I (we) agree that the Canine Work and Games LLC (C-WAGS) and Good As Gold Training (host organization/venue) have the right to refuse this entry for any cause, which the organizing committee alone shall deem to be sufficient. In consideration of the acceptance of this entry, of the holding of the event, and of the opportunity to have the dog participate and/or to be judged, I (we) agree to hold the organizing committee, C-WAGS and Good As Gold Training including their members, officers, directors, agents, and employees, sponsors of the event, and owners of the premises upon which the event is held and their employees harmless from any claim for loss or injury that may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for such claim. I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, appearance, theft, damage, or injury be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for an agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries including death resulting at any time therefore sustained by any person or persons, including my (our) participation in this event, howsoever such injuries, death, or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

I (we) further acknowledge that I (we) have read, understand, and will abide by the Official Rules and Regulations of the Canine Work and Games LLC and the provisions for entry as set further in the Nosework Test Schedule of which this entry form is part. I (we) acknowledge and represent that the information supplied by me (us) herein is correct to the best of my (our) knowledge; if any portion of this information is found to be invalid or insufficient to establish the validity of my (our) entry, such finding shall render my (our) entry invalid in its entirety for which there shall be no refund of fees paid.

Further, I (we) represent that I am (we are) the owner(s) of the dog listed hereon, or that I am (we are) a family member of the dog's owner as stated and allowed in the C-WAGS rules, and that I (we) shall hold the hosting club, C-WAGS and Good As Gold Training, including their officers, directors, employees, and agents and their spouses, harmless from any liability or claim made by the dog's owner(s).
